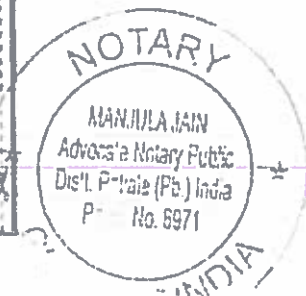

7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation and examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the same and the law of the land.
8. That the school will ensure compliance with all statutory requirements like EPF, ESI, and Labour Laws, etc., with respect to the school and its staff.
9. That the school will ensure that Building Safety, Fire Safety, Water Safety, Health, and Hygiene certificates are issued or renewed by the concerned municipal or state authorities from time to time as per prescribed norms.
10. That the school will ensure that all required infrastructure is available before starting classes.
11. That the school will ensure that a sufficient number of qualified teachers, as per affiliation bye-laws, are available before starting classes.

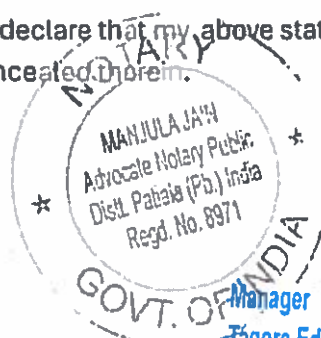
